1. READ AND FOLLOW ALL INSTRUCTIONS

2. WARNING: When using electrical products, basic precautions should always be followed, including the following:

3. DANGER: To reduce the risk of injury, do not permit children to use this unit unless they are closely supervised at all times.

4. Use this unit only for its intended use as described in this manual. Do not use attachments not recommended by the manufacturer.

5. Never drop or insert any object into any opening.

6. Do not operate this unit without the guard over the suction fitting.

7. DANGER: RISK OF ELECTRIC SHOCK. The unit must be connected only to a supply circuit that is protected by a ground-fault circuit-interrupter (GFCI) or Earth-Leakage Circuit-Breaker (ELCB). Such a GFCI should be provided by the installer and should be tested on a routine basis. To test the GFCI, push the test button. The GFCI should interrupt power. Push the reset button. Power should be restored. If the GFCI fails to operate in this manner, the GFCI is defective. If the GFCI interrupts power to the bathtub without the test button being pushed, a ground current is flowing, indicating the possibility of an electric shock. Do not use this hydromassage bathtub. Disconnect the hydromassage bathtub and have the problem corrected by a qualified service representative before using.

8. WARNING: RISK OF ELECTRIC SHOCK. A licensed electrician should make all electrical connections. Disconnect power before servicing.

9. WARNING: RISK OF INJURY OR PROPERTY DAMAGE. Please read all instructions thoroughly before beginning installation, including the following requirements.

10. Follow all local plumbing and electrical codes.

11. INSTALL TO PERMIT ACCESS FOR SERVICING.

12. (For permanently connected units) A green-colored terminal (or a wire connector marked G, GR, Ground, or Grounding) is provided within the terminal compartment. To reduce the risk of electric shock, connect this terminal or connector to the grounding terminal of your electric service or supply panel with a conductor equivalent in size to the circuit conductors supplying this equipment. A pressure wire connector is provided on the exterior of the pump or control within this unit to permit connection of a bonding conductor between this unit and all other exposed metal in the vicinity, as needed to comply with local requirements.

GROUNDING IS REQUIRED. The unit must be installed by a qualified service representative, and grounded. Building materials and wiring should be routed away from the pump body and other heat-producing components of the unit.

WARNING: Unauthorized modification may cause unsafe operation and poor performance of the bath. Do not relocate the pump, or make other modifications to the circulating system, as this could adversely affect the performance and safe operation of your bath. Aquatica Plumbing Group Inc. shall not be liable under its warranty or otherwise for personal injury or damage caused by any such unauthorized modification.

PRODUCT INSPECTION

Carefully unpack the product and inspect the unit for damage. Return the unit to the carton during construction to prevent damage.

FACTORY-ASSEMBLED FEATURES

Factory installed components include components like pump, blower, level sensors, in-line heater, submerged chromotherapy lights, keypad and diverter. The pump and piping are factory-assembled.

CONNECTIONS AND SERVICE ACCESS

NOTICE: For built-in and corner bathtubs provide unrestricted service access to the pump, heater and control box. Provide unrestricted service access to the pump, blower, in-line heater, and for built-in bathtubs you must construct an access panel to provide sufficient clearance for servicing the pump, inline heater, and control box. The access panel must be located immediately next to the pump and in line heater. Study the roughing-in information.



ELECTRICAL REQUIREMENTS

1. **DANGER: RISK OF ELECTRIC SHOCK.** The installation must have one (1) Class A Ground Interrupters (GFCI's) or Earth-Leakage Circuit Breakers (ELCB's). The GFCI/ELCB protects against line shock hazard. **Use a 208V-240V, 20A, 50/60 Hz dedicated service to wire the control system.**
2. **GROUNDING IS REQUIRED.** The unit should be installed by a qualified service representative and grounded.
3. Installation instructions shall identify fittings, such as brackets or hangers, that are necessary to the intended mounting of the unit.
4. The minimum structural strength required for the supporting surface for the unit. Need to provide rough in instructions to review for compliance.
5. Instructions shall indicate that building materials and wiring should be routed away from the pump body and other heat producing components.
6. **INSTALL TO PERMIT ACCESS FOR SERVICING**
7. An equipment bonding terminal is provided in the field wiring compartment. To reduce the risk of electric shock, this terminal must be connected to the bonding means provided in the electric supply panel with a conductor equivalent in size to the circuit conductors supplying this equipment.

The effects of hyperthermia include:

- Unawareness of impending hazard
- Failure to perceive heat
- Failure to recognize the need to exit the hot tub
- Physical inability to exit the hot tub
- Fetal damage in pregnant woman
- Unconsciousness resulting in the danger of drowning

If you sense any of the symptoms of hyperthermia, safely exit the hot tub immediately.

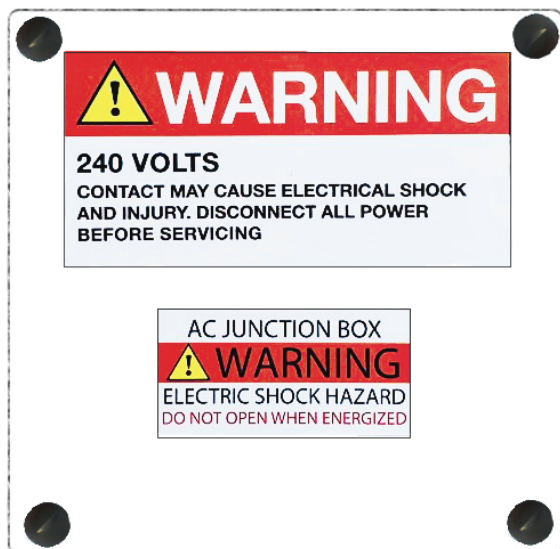

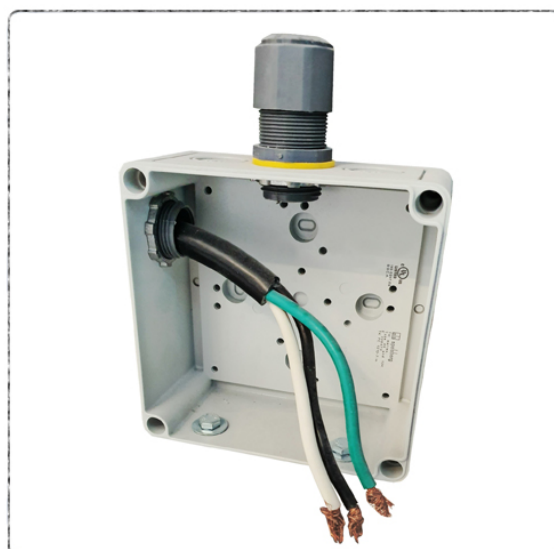
AC JUNCTION BOX

Connect to your home electrical system via our AC junction box solely! Use #12 AWG size wire and 20A breaker to connect to your home's electrical system.



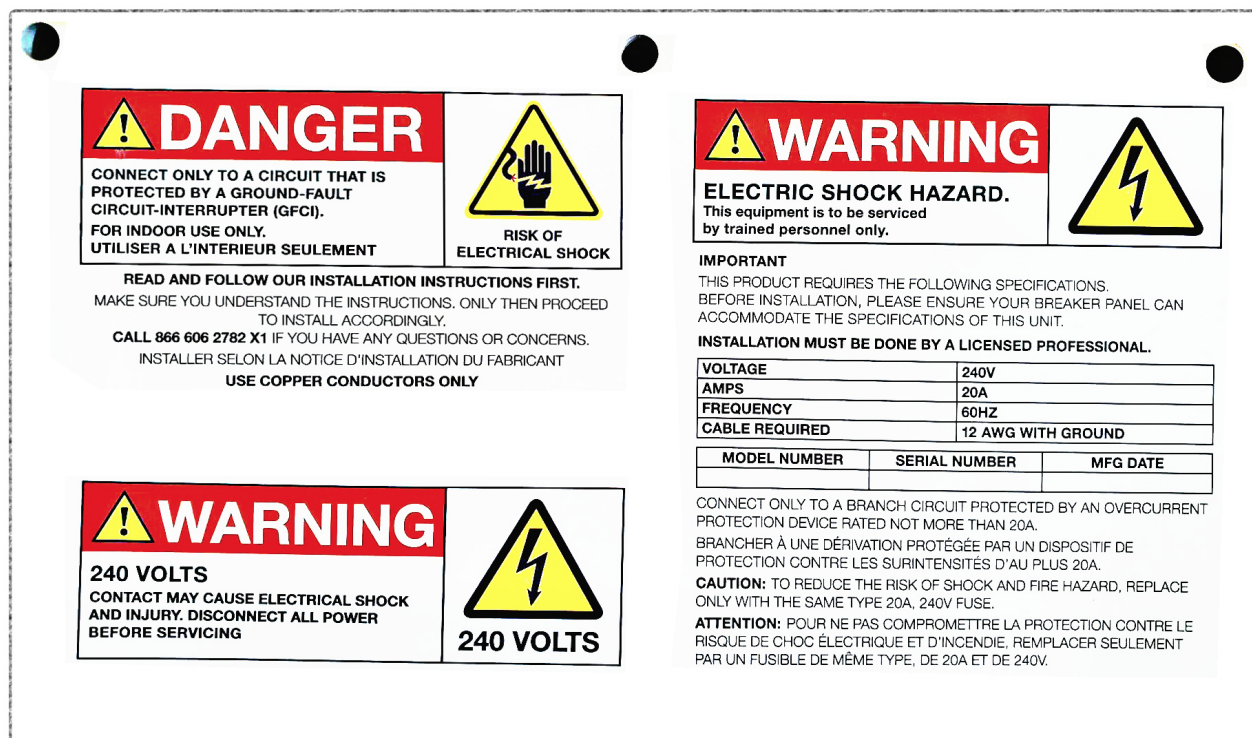
JUNCTION BOX WIRE COLOR MARKINGS:

BATH CONTROLLER ENCLOSURE

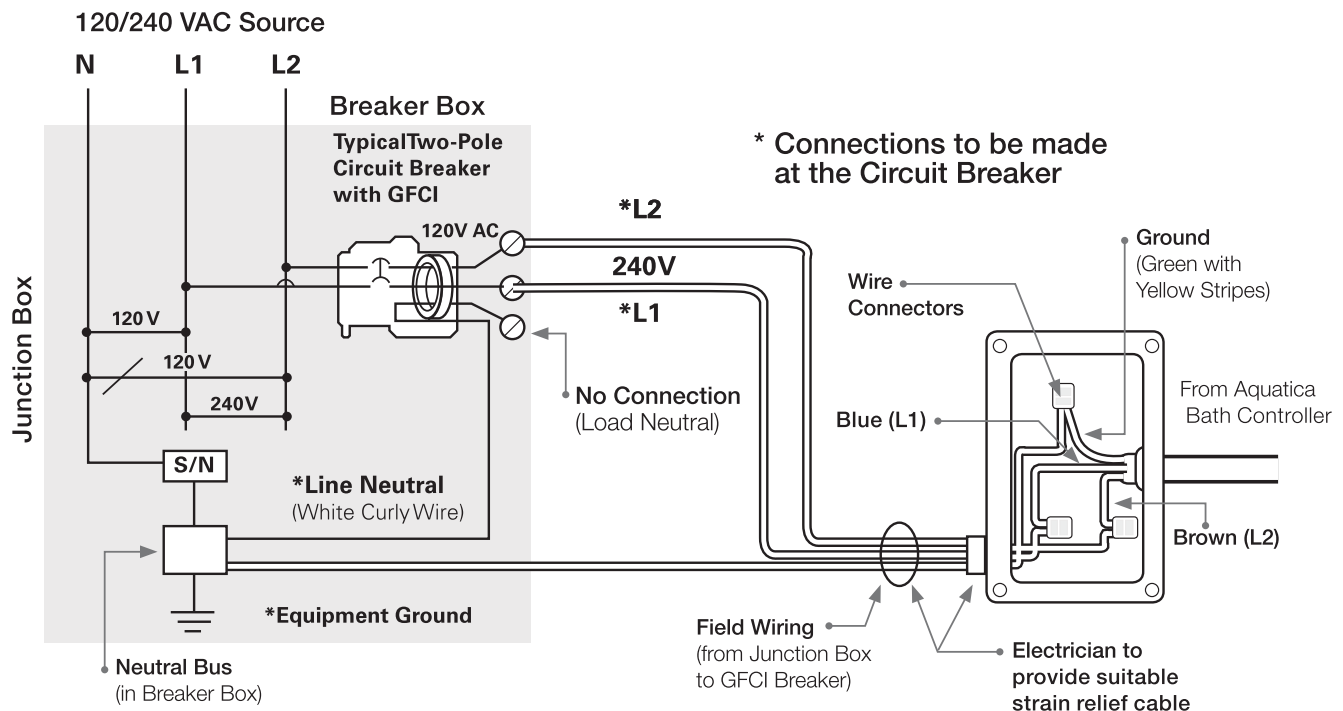
Do not tamper with our bath controller enclosure. It is pre-configured and pre-wired. Opening and tempering might void our warranty.

Make the Electrical Connections

IMPORTANT!

The Aquatica® Spa series hydromassage bathtubs come equipped with a wiring junction box and are designed to operate between 208 VAC and 240 VAC at either 50 Hz or 60 Hz.

IMPORTANT!

While the Aquatica® Bath Controller is designed to operate between 208 VAC and 240 VAC at either 50 Hz or 60 Hz, the pumps are market specific and require the correct frequency that is applicable for your specific market.

Our US/Canadian Spa series bathtubs ship with 60Hz pumps, while our International models ship with 50Hz pumps.

WARNING!

Risk of electrical shock. Make sure the power has been disconnected before performing the following procedures. Refer to the "Important Information" section.

WARNING!

Risk of electrical shock. To reduce the risk of electrical shock, connect the system to properly grounded Ground-Fault Circuit-Interrupter (GFCI) or Earth-Leakage Circuit-Breaker (ELCB).

This will provide additional protection against line-to-ground shock hazard. One 208-240V, 20A, 50/60Hz dedicated circuit is required.

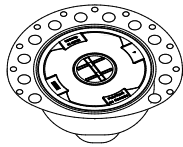
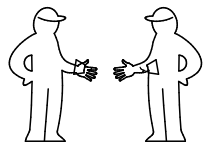
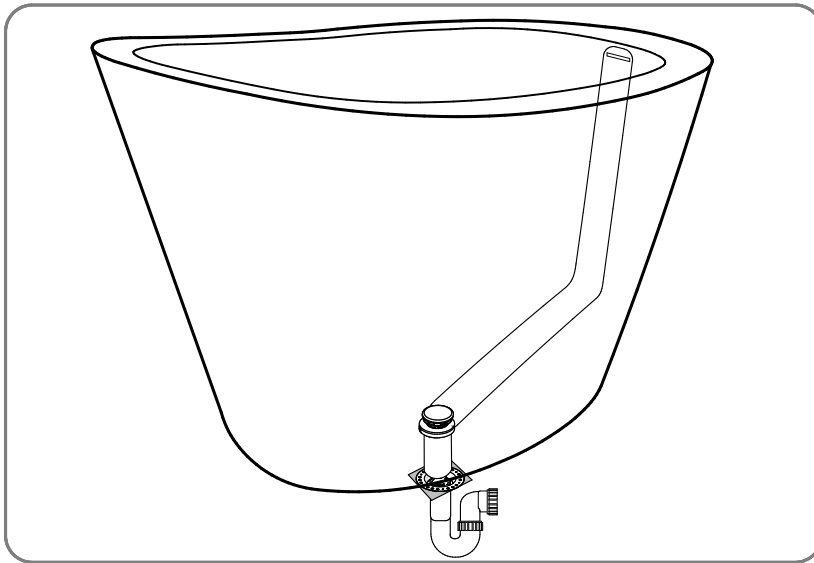
IMPORTANT!

The load neutral is not used. There should be no connection to the load neutral terminal on the Ground-Fault Circuit-Interrupter (GFCI) breaker. The green wire with the yellow stripes is the equipment ground and needs to be connected to the neutral bus in the main circuit breaker box.

- The Aquatica® Bath Controller, pumps, blower, lights and heater have been pre-wired at the factory. A licensed electrician should make a routine service connection to the junction box.
- Connect service to the junction box. The junction box contains blue, brown, and green with yellow stripe colored wires.
- Follow local electrical codes. Bond in accordance with national and local codes.
- A wiring harness has been pre-wired at the factory, allowing communication between the junction box, and the Aquatica® Bath Controller. No additional wiring is required, but ensure that all wires are securely fastened.

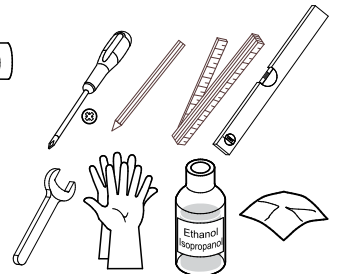
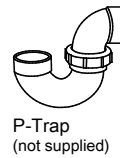

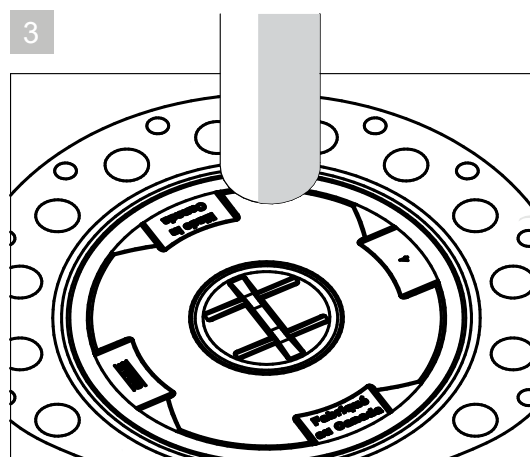
Attaches to Freestanding Bath W/O



- A. Cut 5" (12.7cm) hole into wood sub-floor (use supplied Cutout Template).
- B. Measure and cut ABS Tailpiece as necessary to ensure a secure connection to P-Trap below.
- C. Insert Freestanding Bath Installer™ assembly into floor opening and connect to Pipe below.
- D. Affix to sub-floor with 6 screws (not supplied)



- A. Install flooring surface, leaving a 5" opening to access Drain.
- B. Affix the appropriate brass Tailpiece to the Waste & Overflow. **NOTE: DO NOT CUT THE BRASS TAILPIECE AS THIS MAY CAUSE A LEAK.** Ensure the measurement between the base of the Drain and P-Trap will accommodate the Tailpiece. Other lengths available (contact Aquatica).



- A. Cut out the Installation Label with a utility knife and remove to expose the Drain.
- B. Apply lubricant (supplied) to the Tailpiece.
- C. Position the Tub and brass Tailpiece in-line with the Drain.
- D. Carefully lower the tub with the installed brass Tailpiece into the Red Collar in Drain assembly. Ensure Tailpiece is fully engaged with Seal.

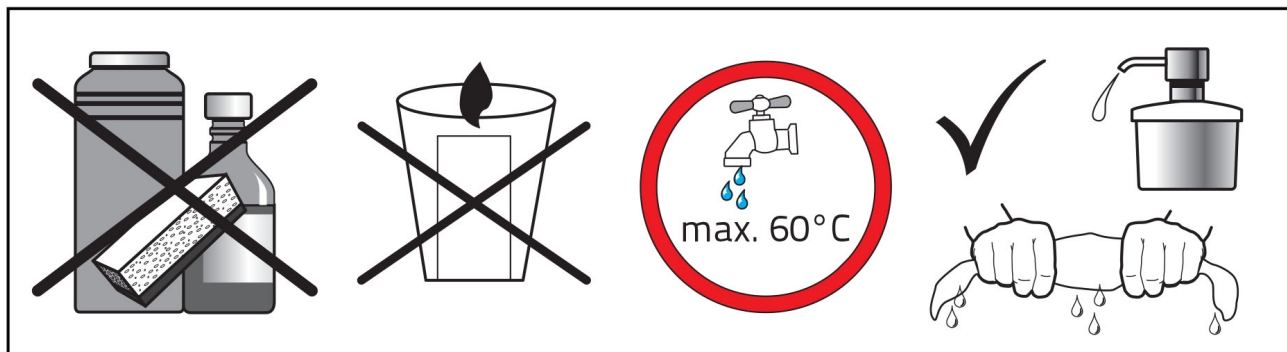

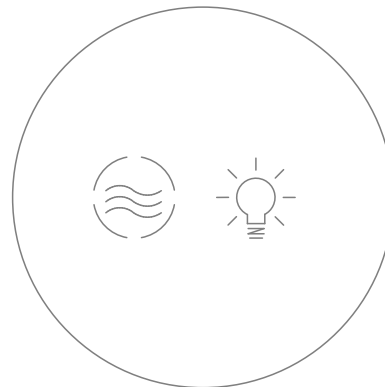

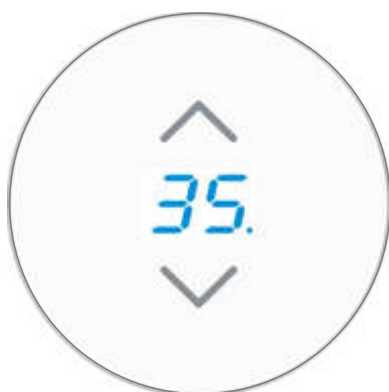
The control system consists of
2 keypads as follows:

On/Off and Lights On/Off



Activate the heating and circulation feature by touching the  icon, the icon will light up when activated. This feature will only activate once sufficient water level has been reached. As per safety regulation, the heating feature is programmed to automatically shut down after 20 minutes from time of activation, simply touch the  icon again to reactivate.

Activate the lighting feature by touching the  icon, the icon will light up when activated. Tap to cycle through the various modes/effects, similar to what is depicted on the image below. Touch and hold for a few seconds to turn off.



Temperature Adjustment Function

The round 2-digit display is the temperature controller. When the Tranquility is powered it will reflect the current water temperature. By tapping the up or down icon, it will increase or decrease set temperature. When increasing or decreasing set temps, the display will change from current water temperature to reflect settings temperature. The setting temperature will show for a few seconds when adjusting before changing back to current water temperature. The maximum allowed temperature is +40C (104F).

CURRENT SYSTEM LIMITATIONS

Temperature Adjustment Function in 220V Systems

The Tranquility heating system in the 220V/240V systems is intended to maintain the temperature.

Temperature Display in Degrees (220V) / Fahrenheits (240V)

Please note that since the display is a 2-digit display after exceeding 99F the temperature will be displayed according to the following format:
